

Knight Time Hockey Bar – Away Game Drawing Rules

1. The Away Game Drawings will be held starting on Sunday, November 5, 2023 through April 10, 2024 inside the Knight Time Hockey Bar during every Vegas Golden Knights (VGK) away game.

Eligibility

- 2. Open to the public.
- 3. A valid government or state issued photo ID is required to verify age and identity. Participants must be 21 years of age or older to participate.

Drawing Rules

- 4. All guests inside the Knight Time Hockey bar during every VGK away game will receive one (1) raffle ticket starting on Sunday, November 5, 2023 through April 10, 2024. Ticket distribution starts 30 mins before puck drop and ends at the beginning of the 3rd period. Tickets will be distributed by a Knight Time Hockey Bar Staff Member.
- 5. Only one (1) raffle ticket per guest per VGK Away Game day. There will be no earn-ups for additional entries.
- 6. At the end of the 3rd period, one (1) winner will be drawn to win various hockey prizes.
- 7. Guests must be present to win and have one (1) minute to claim their prize. If the winner is not present, another name will be drawn until a winner is found.
- 8. Prize winnings may be subject to taxes and require W-9 forms to be completed. See Rules #11 and 14.
